The IPBA's Dispute Resolution and Arbitration Committee successfully organised the Inaugural IPBA ASIA-PAC Arbitration Day in Kuala Lumpur, Malaysia on 14 September 2015. This signature initiative of the Committee's Co Chairs Ms Juliet Blanch and Mr. Mohan Pillay was jointly hosted by the Kuala Lumpur Regional Centre for Arbitration (KLRCA) and was held at the KLRCA's new premises at Sulaiman Building, Kuala Lumpur.

Following the welcome Address by the Organising Chair of the IPBA ASIA-PAC Arbitration Day, Mr. Mohanadass Kanagasabai of Messrs Mohanadass Partnership, Kuala Lumpur; the conference was officially opened by the Director of KLRCA, Datuk Professor Sundra Rajoo. The Right Honourable Lord Justice Sir Jack Beatson, Lord Justice of Appeal, England & Wales delivered the Keynote Address entitled "Public Policy Considerations on Conflict of Law in International Arbitration."





Building on the Keynote Speech, the focus of the first session of the conference was the topic "The Application of Conflict of Laws Rules in Arbitral Disputes". The session was moderated by Mr. Mohan Pillay, Pinsent Masons MPillay, Singapore and Co-Chair of the Dispute Resolution & Arbitration Committee of IPBA. Distinguished practitioners and academicians from the region made up the first panel namely, Mr. Christopher To of Messrs Christopher Wing To, Hong Kong, Mr. Chan Leng Sun SC of Baker & Mckenzie, Wong & Leow, Singapore, Mr. Lionel Persey QC, of Quadrant Chambers, London and Professor Benjamin Hughes of Seoul University, Korea.















After the morning coffee break, the conference resumed on the hot-button topic of "Costs of Arbitration and Third Party Funding". The session was moderated by Mr. Kevin Prakash, Mohanadass Partnership, Kuala Lumpur and President of the Malaysian Institute Arbitrators. Panellists were Ms. Tan Ai Leen, Registrar, SIAC, Mr. Richard Keady, Bird & Bird, Hong Kong SAR, Dr. Anton G. Maurer, CMS Hasche Sigle, Germany and Ms. Shanti Mogan, Shearn Delamore, Kuala Lumpur. The session proved to be of great interest to the delegates with many questions from the floor.





The third session on "The Operation of Confidentiality and Privilege in International Arbitration" moderated by Mr. Sivakumar Kanagasabai of SKRINE, Kuala Lumpur, had the participants thinking on their feet and exchanging views on a hypothetical scenario on confidentiality and privilege. The final session dealt with a niche topic "Multifaceted Contemporary Issues in Maritime Dispute Resolution". The session was chaired by Judge of the Malaysian Court of Appeal, Her Ladyship Datuk Nallini Pathmanathan. The session proved to be highly interesting to both specialists and general practitioneers alike.
